## Terms and Conditions of Entry

**Opening Date:** 1 March 2005

**Closing Date:** 15 June 2005 (entries must be postmarked by this date to be accepted)

**Number of Words:** Maximum 3000 per story

**Prizes:** First \$400.00 Second \$100.00 2 x Highly Commended \$50.00

**Entry Fee:** \$7.00 per story (maximum of three stories per author) **Cheque/Money Order payable to FAWWA**

1. All work must be previously unpublished. Work broadcast or plays performed are classified as published.
2. The Fellowship of Australian Writers (WA) reserves the right to publish the winning, second place and highly commended entries in its publications (including web site). Results will be published in FAWWA publications.
3. Non-award winning manuscripts are destroyed after the competition and will not be returned. Ensure you keep a copy.
4. **A pen name must be used and CHANGED for each story. The real name of the author must not appear on the manuscript.**
5. **Each story must have a cover page with only the following information; Competition, Title of Story, Pen Name**
6. **A COMPLETED entry form must be enclosed.** Ensure all sections are filled out and the entry form is signed.
7. Entry fee of \$5 per story should be made by cheque or money order made payable to FAWWA. Sending of cash is not recommended and if undertaken is at competitors own risk. **Note: No other form of payment is acceptable.** We will not accept payment by stamps or any manner other than cheque/money order.
8. The judge's decision is final. Competitors must not communicate with the judge before or during the competition.
9. If a list of prize winners is required, please send a stamped, self-addressed envelope with your entry.
