### AGENCY TERMS AND CONDITIONS

#### WHEREAS

1. The artist, gallery or studio completing the Entry Form ("The Artist") appoints Iona Presentation College ("The Agent") as its sole Agent to offer identified artwork(s) for sale on consignment during the period of the said exhibition.
2. The Agent consents to offer the identified artwork(s) for sale at the exhibition subject to its sole discretion.
3. The Artist warrants that it possesses unencumbered title to the identified artwork(s).
4. The Artist indemnifies the Agent against the effect of any false, misleading or inaccurate declarations by the Principal, including description of the Artist's status with respect to liability for Goods and Services Tax (GST).

#### The Artist agrees as follows:

##### **Entry Form Due Date**

The Artist shall complete the details of each artwork on the Entry Form, and shall sign and return the Entry Form with these Terms & Conditions by Friday 21 September 2009.

##### **Delivery of Artwork**

The Artist shall deliver the artworks for sale to the Iona Sports Centre, Lochee Street Entrance, on Monday 16 November 2009 between 10 and 12am, or 4 and 6pm.

The Artist shall remove unsold artworks between 2 and 4 pm on Monday 30 November 2009 or by special arrangement.

##### **Exhibition Fee**

To be paid with the delivery of your work. \$10 per item or \$25 per Jewellery collection.

##### **Tax Invoice**

The Artist agrees that the Agent will raise and issue a Tax Invoice to each respective purchaser, including GST calculated on the basis of the ABN/GST status declaration provided on the Entry Form by the Artist.

##### **Sale Price**

The Artist shall determine the Sale Price of each artwork (including GST, if applicable).

The Agent shall be entitled to offer the artwork(s) for sale at the Sale Price (including GST if applicable) quoted on the Entry Form).

The Agent shall retain a Commission of 30 per cent of the Base Price (Sales Price less GST if applicable) for each artwork sold.

##### **Ownership and Risk**

The Artist agrees that it shall retain ownership of the artwork(s) at all times, and shall be responsible at its absolute discretion for insuring the artwork(s) against any and all risks. The Agent will exercise due care in handling and protection of the artwork(s) submitted. However, the Artist indemnifies the Agent, its staff and voluntary helpers against any loss or damage whatsoever to artwork(s) whilst in the Agent's custody.

##### **Delivery of Artworks**

The Agent will only accept Artwork(s) on the delivery dates listed above. The Agent reserves the right to accept or reject any artwork(s) submitted for entry.

Due to limited hanging space, some submitted artworks may not be hung, at the sole discretion of the Agent. The Agent will not accept any Painting Entry Piece that is still 'WET' at the time of delivery.

The Artist shall complete stickers provided by the Agent to be attached to the back of each artwork, showing the Artist's name, the title of the piece, the medium of the artwork, and the Sale Price.

For prints, the Artist shall stipulate the number of prints available for sale, and the framed and unframed price of each print where applicable.

##### **Preparation for Hanging**

The Artist shall ensure that each artwork supplied for hanging shall be suitably framed with two (2) 'D' rings firmly affixed at the rear or on the sides, one-third down from the top. Paintings must be wired and ready for hanging.

##### **Unsold Art**

The Artist agrees to remove any unsold Artworks from the Art Exhibition only during the Removal Period. Artwork will be released on Monday 30 November between 4 – 6 pm, upon presentation of works received document.

##### **Payment for Sold Art**

The Agent will provide to the Artist a payment summary and cheque, including GST as appropriate, for all sold artwork entries within fourteen (14) days of the close of the exhibition. The Artist shall declare and pay any GST due to the Australian Tax Office.
